### Credit Reporting Service Participation Agreement

The Undersigned, hereinafter termed Member, hereby enters into this agreement with the Printing Industries of Northern California, hereinafter termed the Association, to act as reporting agency for the purpose of receiving, compiling, and furnishing to the Member for its sole use and benefit, information concerning the payment history of business organizations and individuals with whom the Member has commercial dealings. In return, the consideration to the Association shall be in the form of membership dues and by agreeing to furnish similar information to the Association regarding entities with whom said Member is doing business.

*The Member further agrees as follows:*

1. The Association shall not be liable in any manner for loss or injury to the Member resulting from its procuring collection and communication information.
2. The Association shall not be held liable in any manner for loss or injury resulting from information supplied by said Member to the Association, and said Member will hold the Association harmless from any legal action resulting from information thus supplied by Member.
3. The Member will neither ask for information for the use of other parties nor permit it to be done; all information supplied by the Association to the Member shall be held in strict confidence.
4. It is understood and agreed that the Association does not guarantee the accuracy of any information, but acts merely as a conduit and/or a clearing house of credit information regarding customers or business organizations with whom its members have a direct interest.
5. The Member warrants that it will not request information regarding paying habits of business organizations with whom it does not have a direct interest. The Association will not be placed in a position of reporting said information to members who have only a casual or curious interest.
